<p>Hints to consider when completing the Participant Information Sheet and Participant Consent Form</p> <ul style="list-style-type: none"> • Providing participants with full details of the objectives of the research • Providing information appropriate for those whose first language is not English • Voluntary participation with informed consent • Written description of involvement • Freedom to withdraw • Keeping appropriate records • Signed acknowledgement and understanding by participants • Relevant codes of conduct/guidelines <p>If you have marked YES to observing, interacting or otherwise working with children (under the age 18) or vulnerable adults you MUST provide a Parent/Guardian Consent Form. If you do not supply this supporting document, your application will be automatically rejected.</p> <p>The Parent/Guardian Consent Form must be completed in collaboration with your tutor to ensure all grammatical errors are checked. Please edit this document to fit the remit of your study.</p> <p>If you marked YES to researching into activities that have a risk of distress, discomfort or personal injury to the participants, you must provide a Health and Safety Risk Assessment Form.
